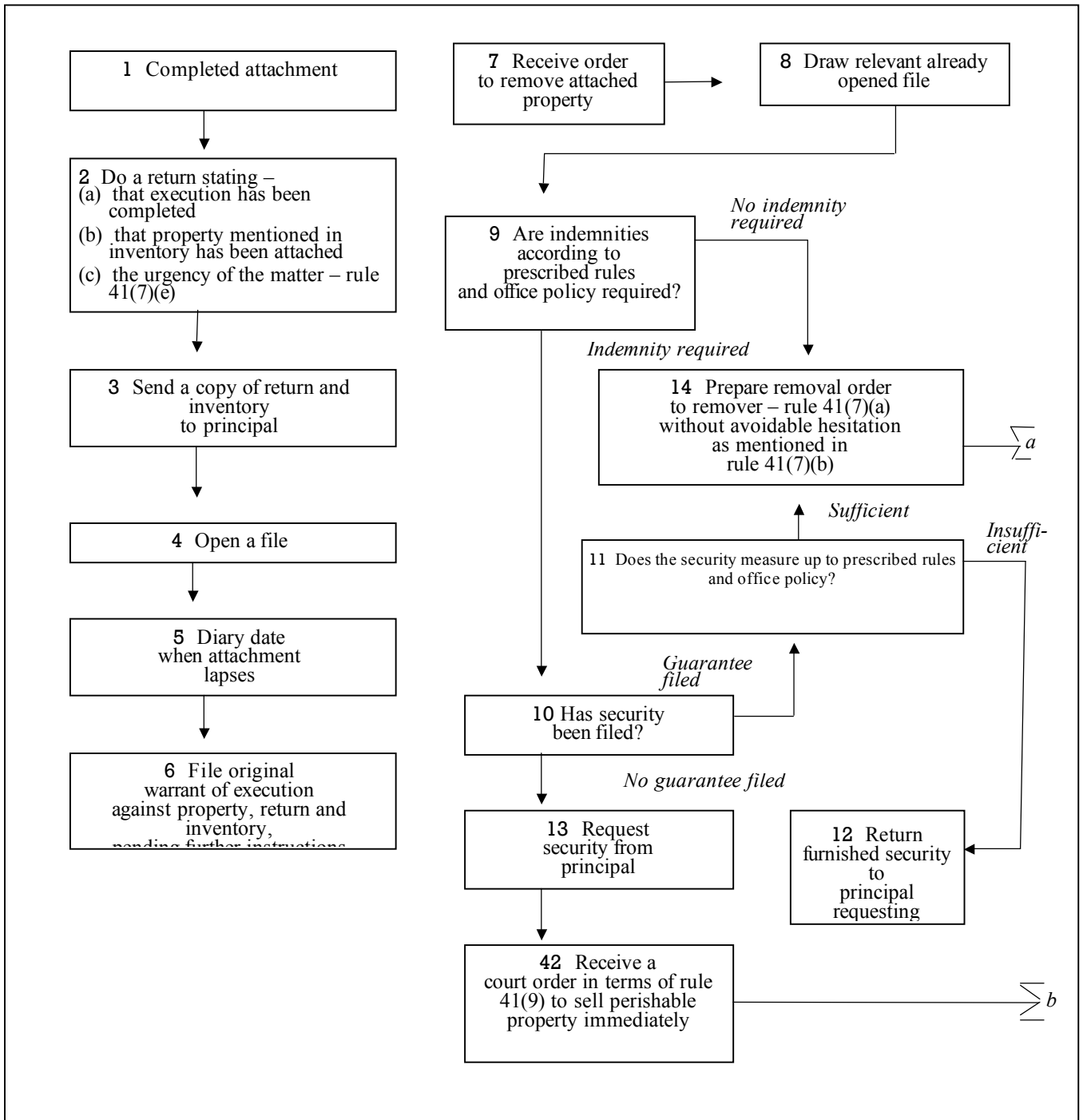


**Diagram 6 – Warrant of execution against property

 Magistrate’s Court – attachment**

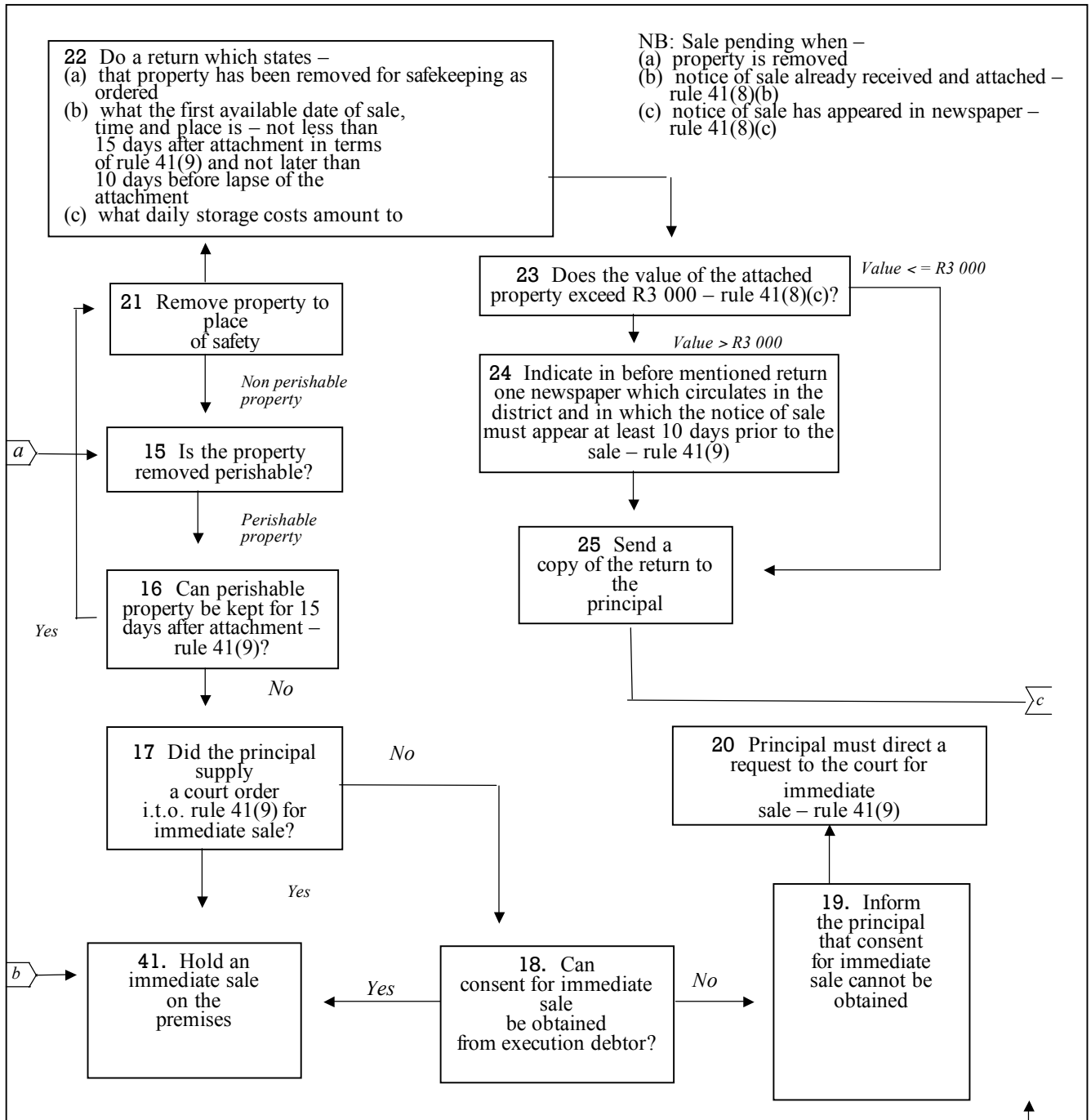

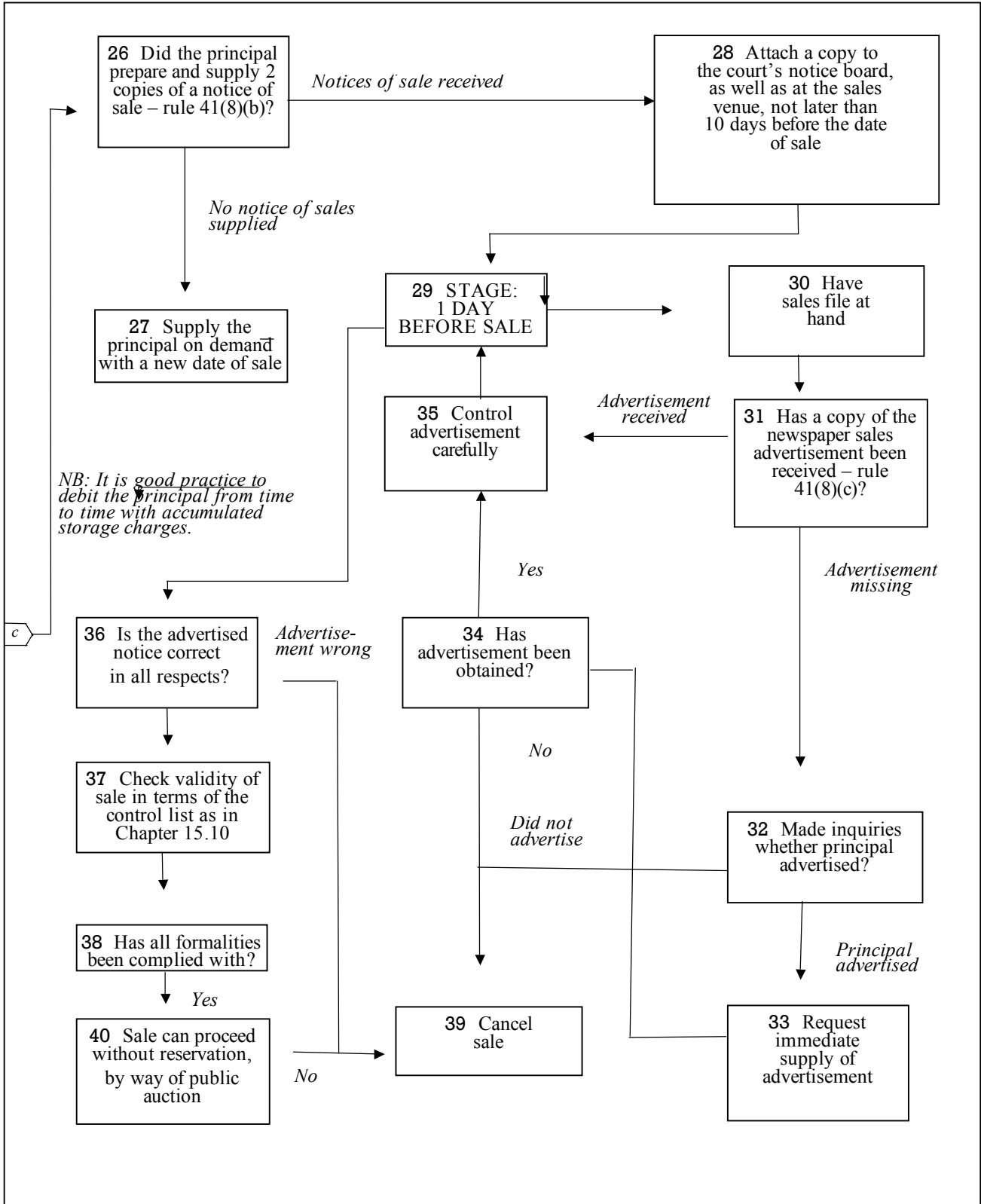

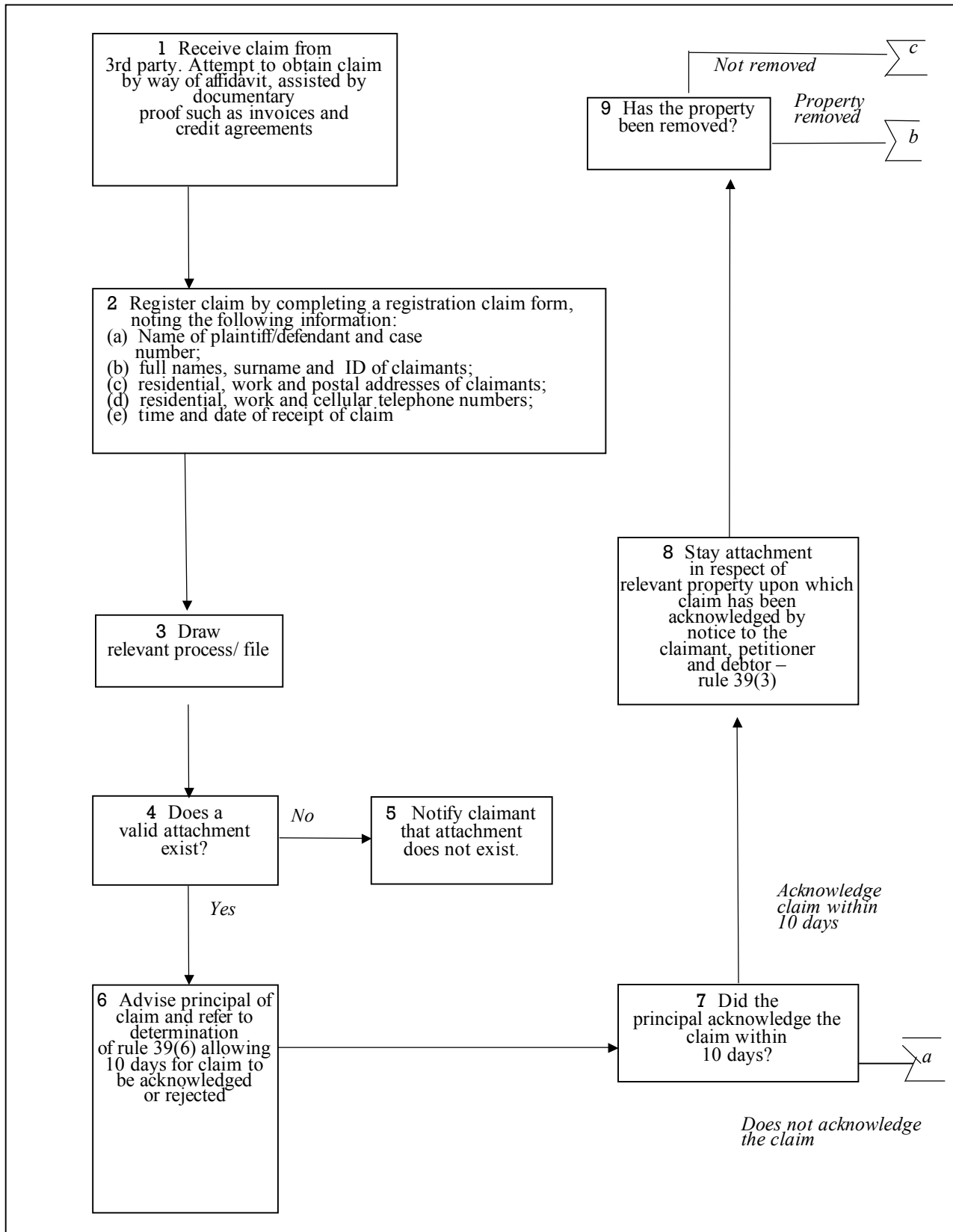

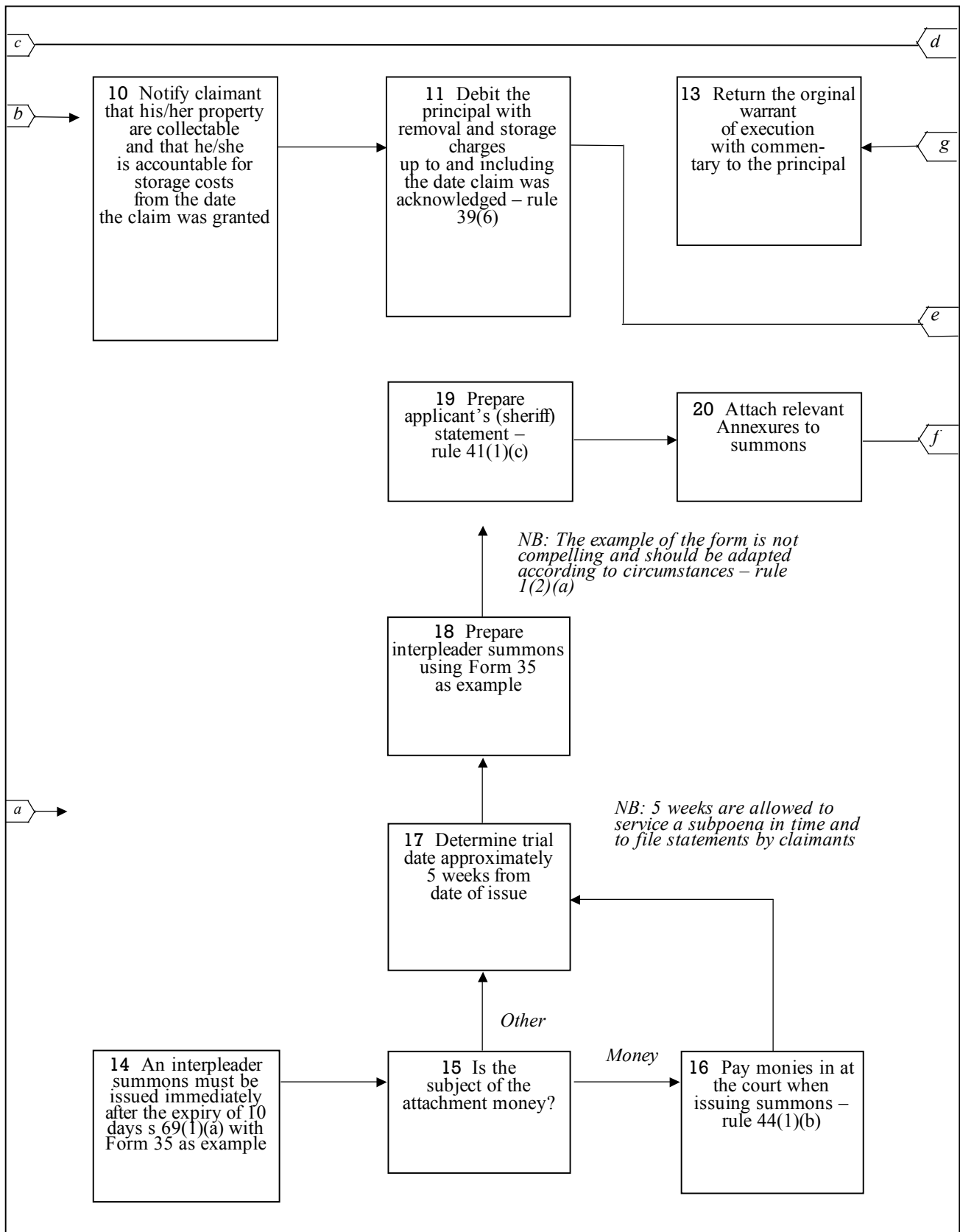

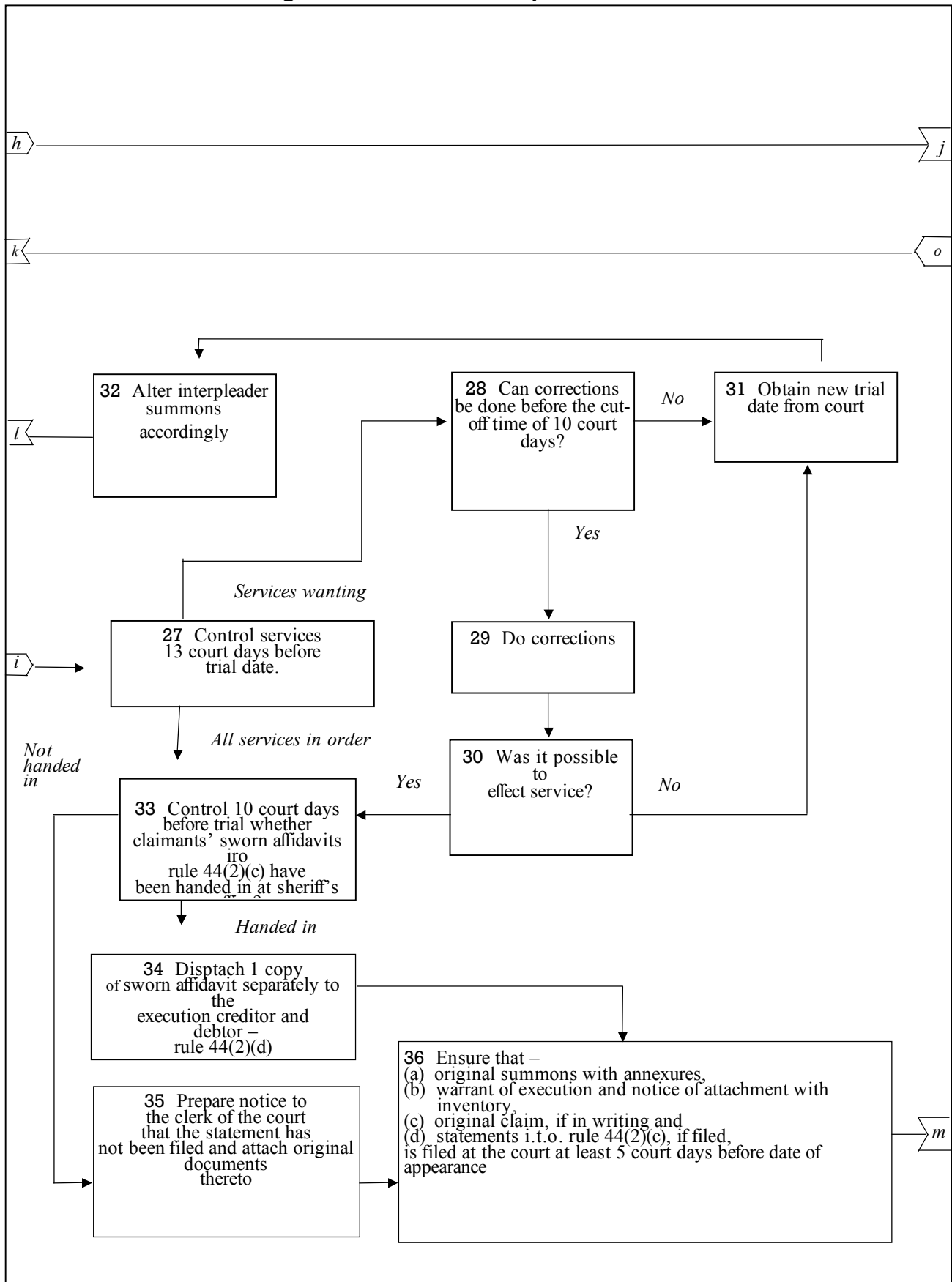
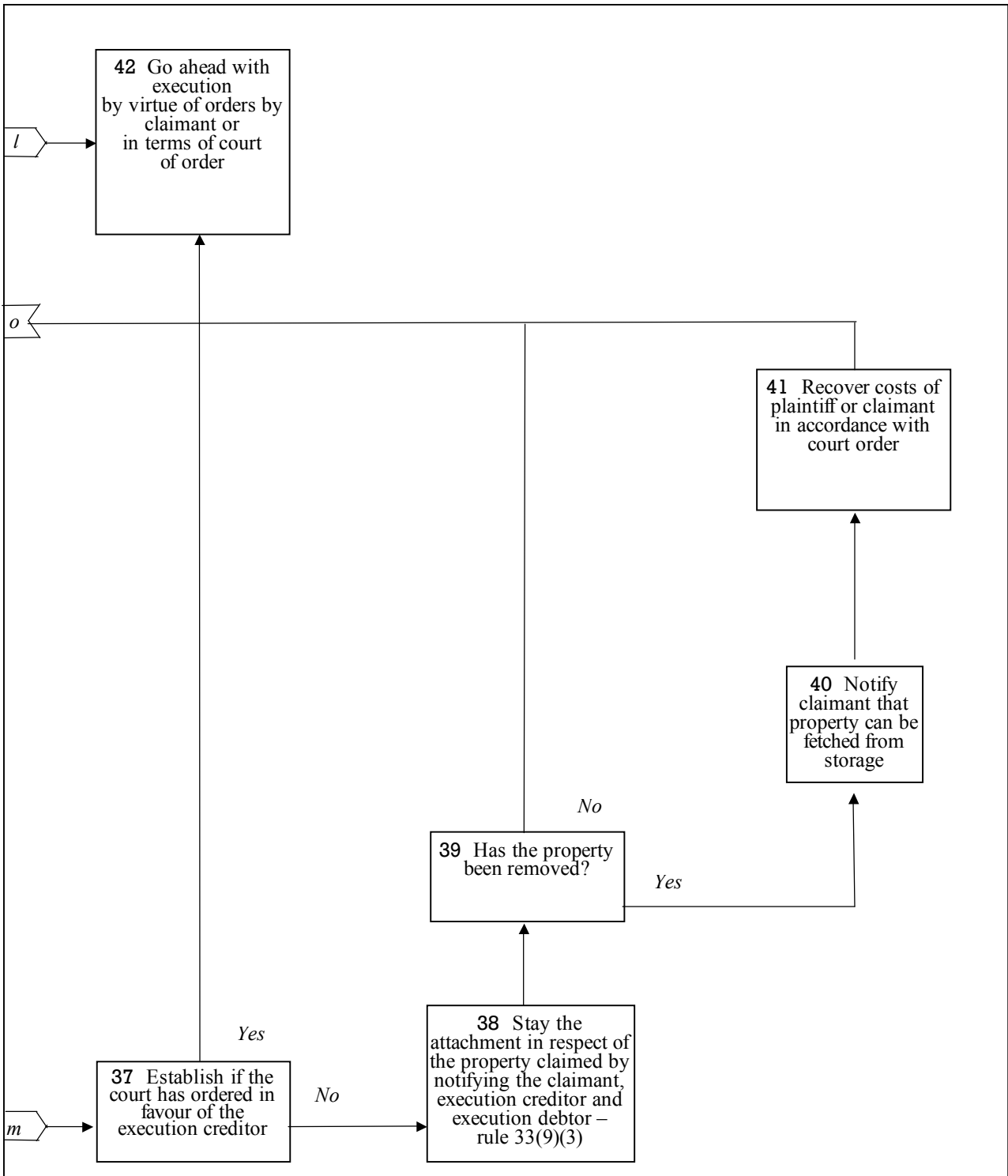


Diagram 7 – (Continued)

 Magistrate’s Court – attachment lapses**

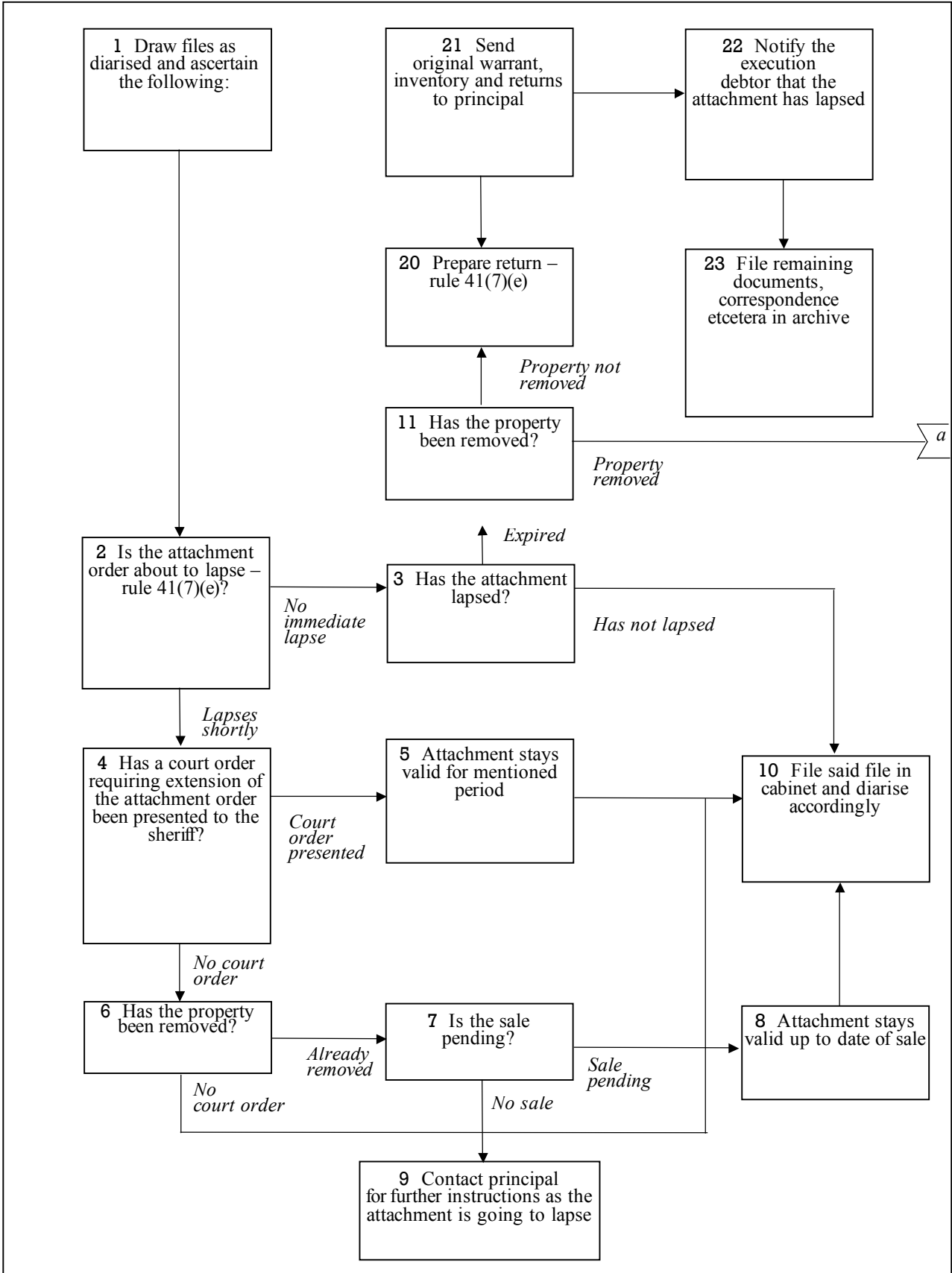
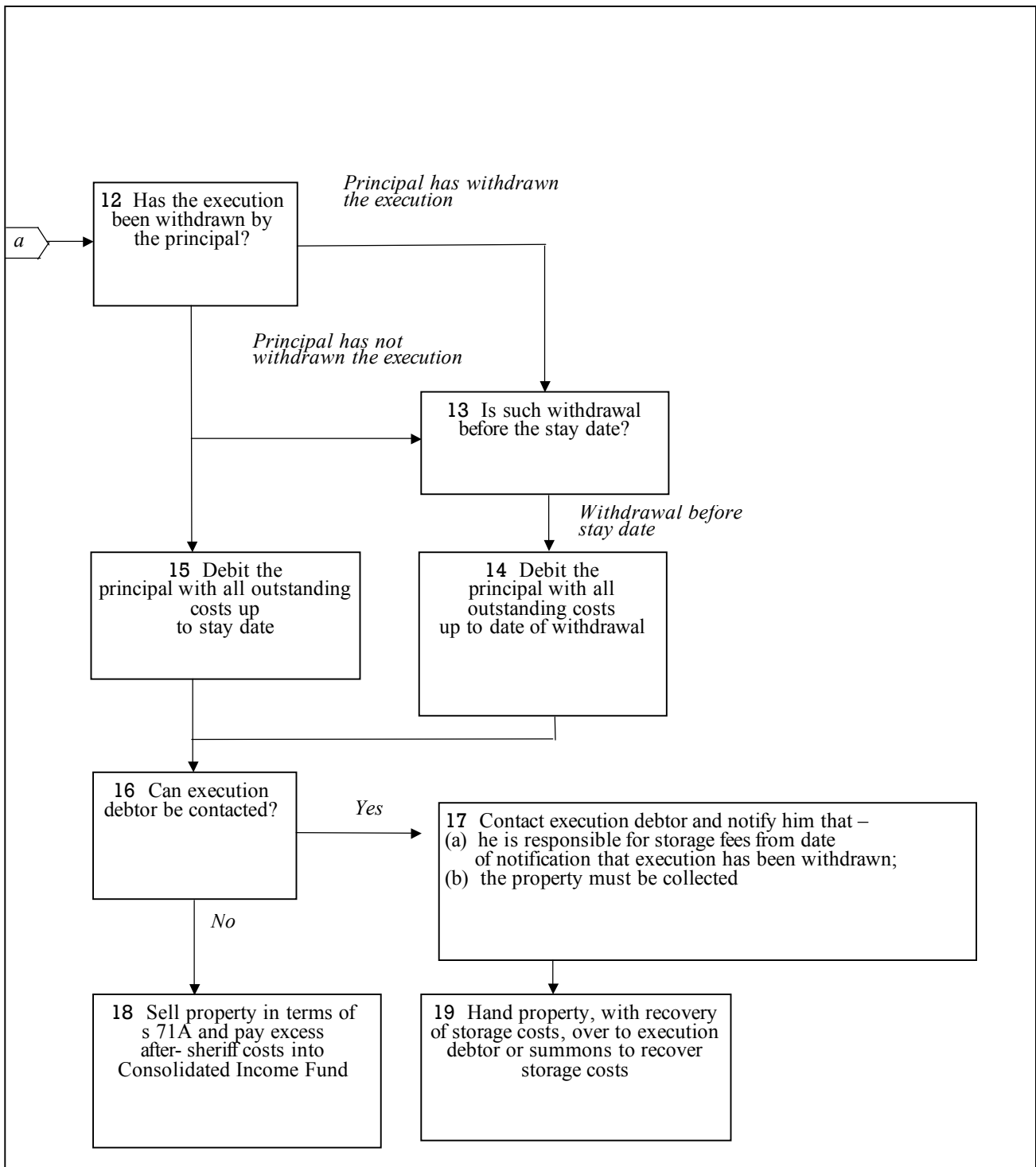
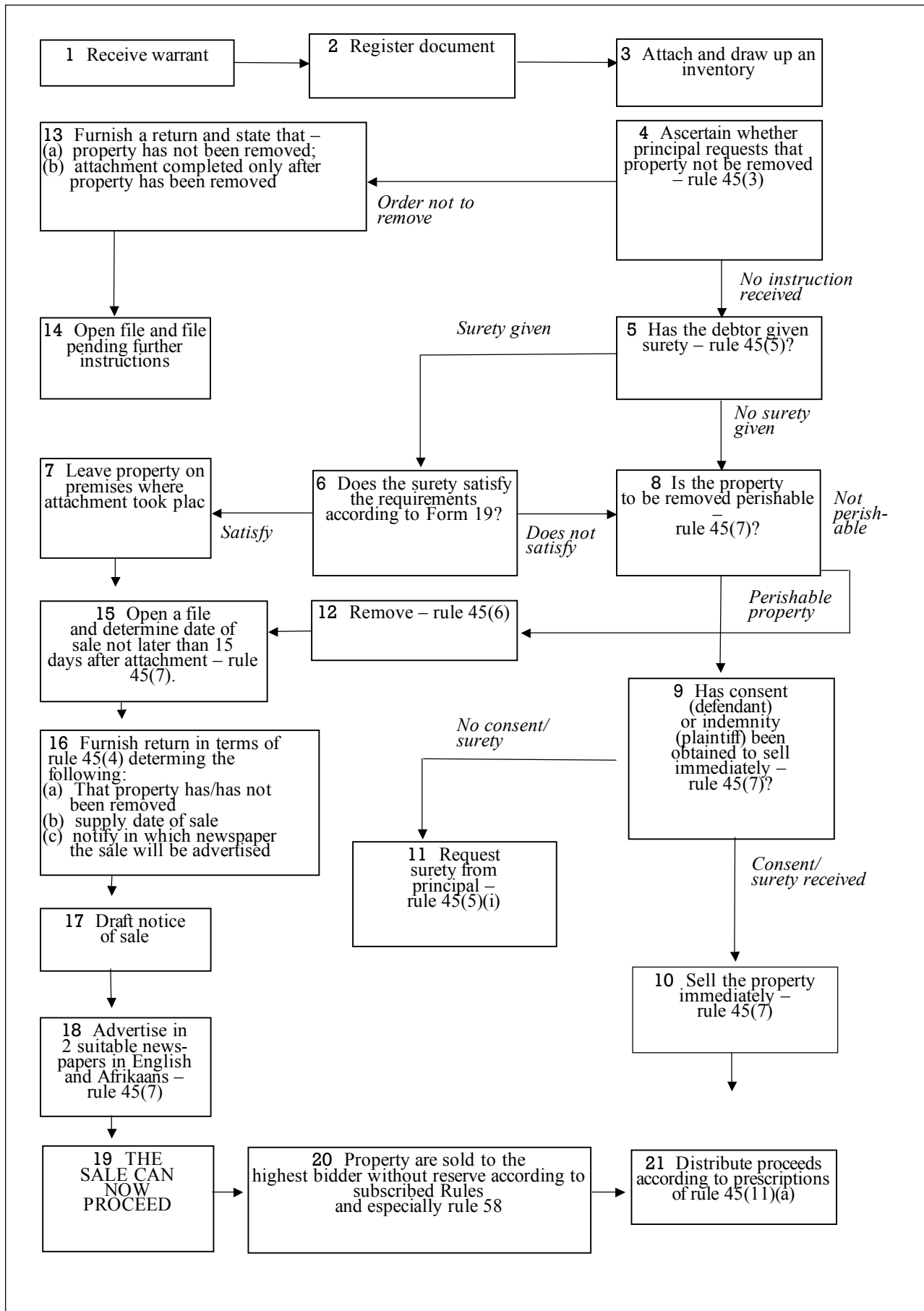

Diagram 10.1 – Warrant of execution against property – immovable property – Magistrate’s Court, as well as warrant for attachment – immovable property – High Court – attachment

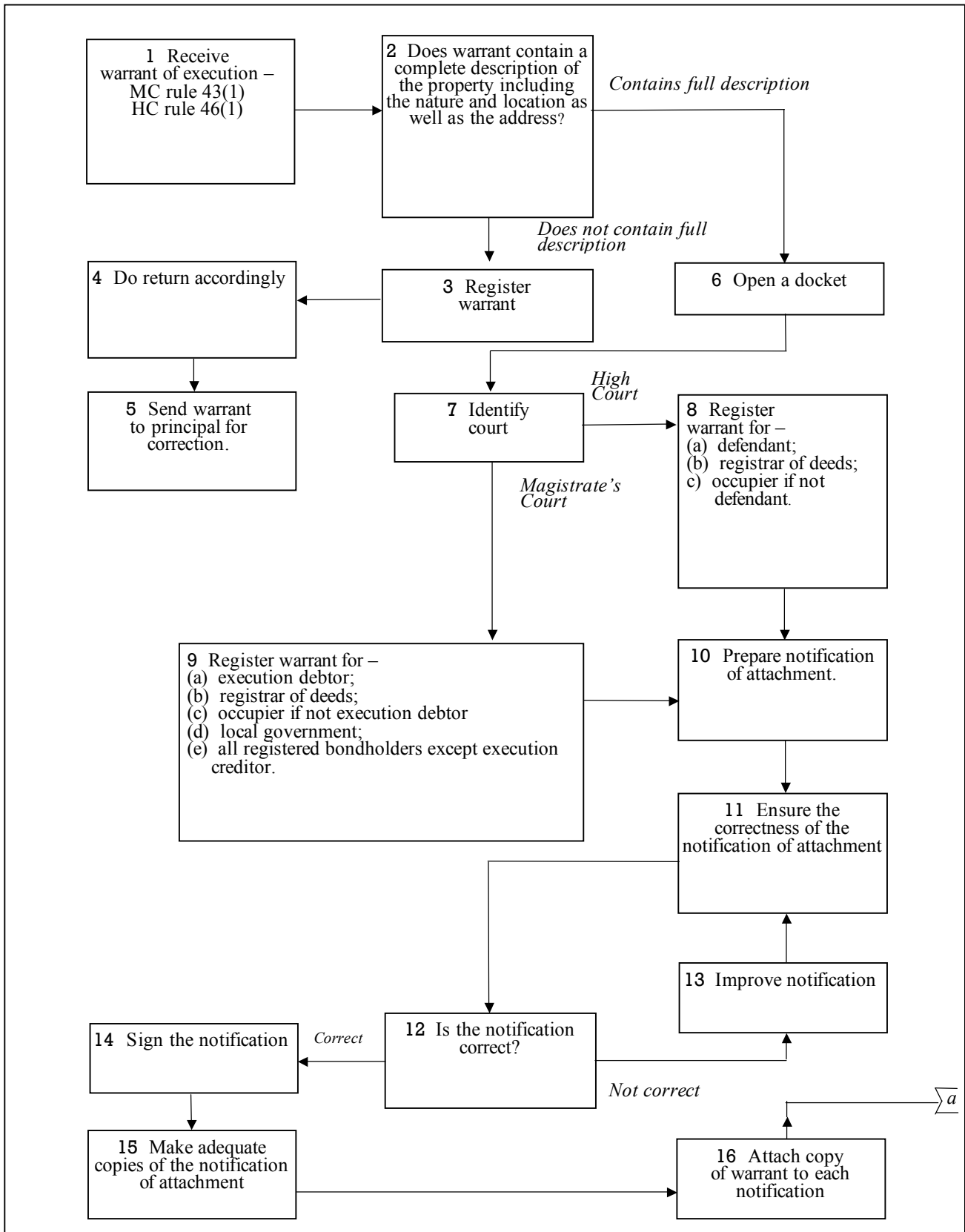

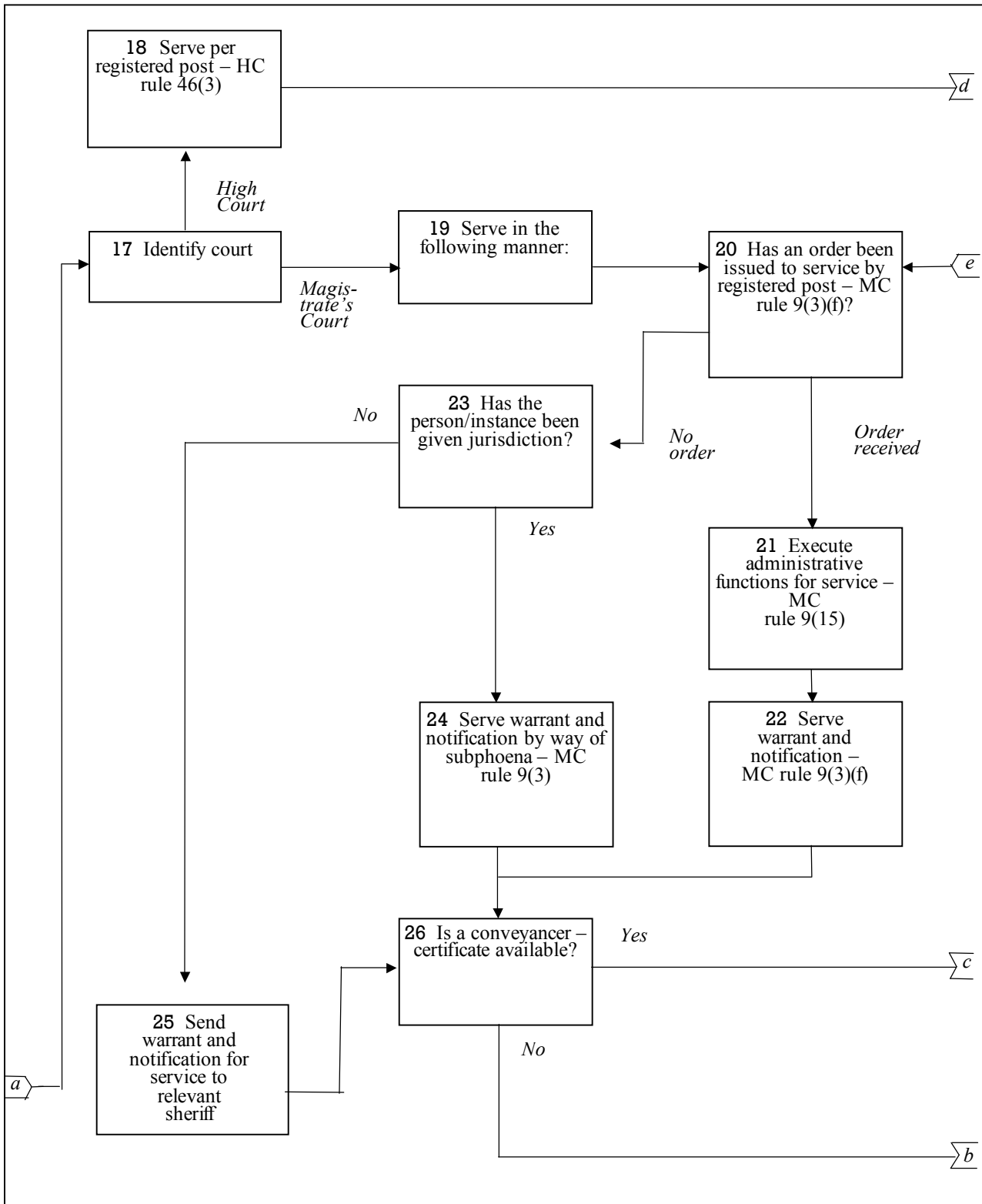

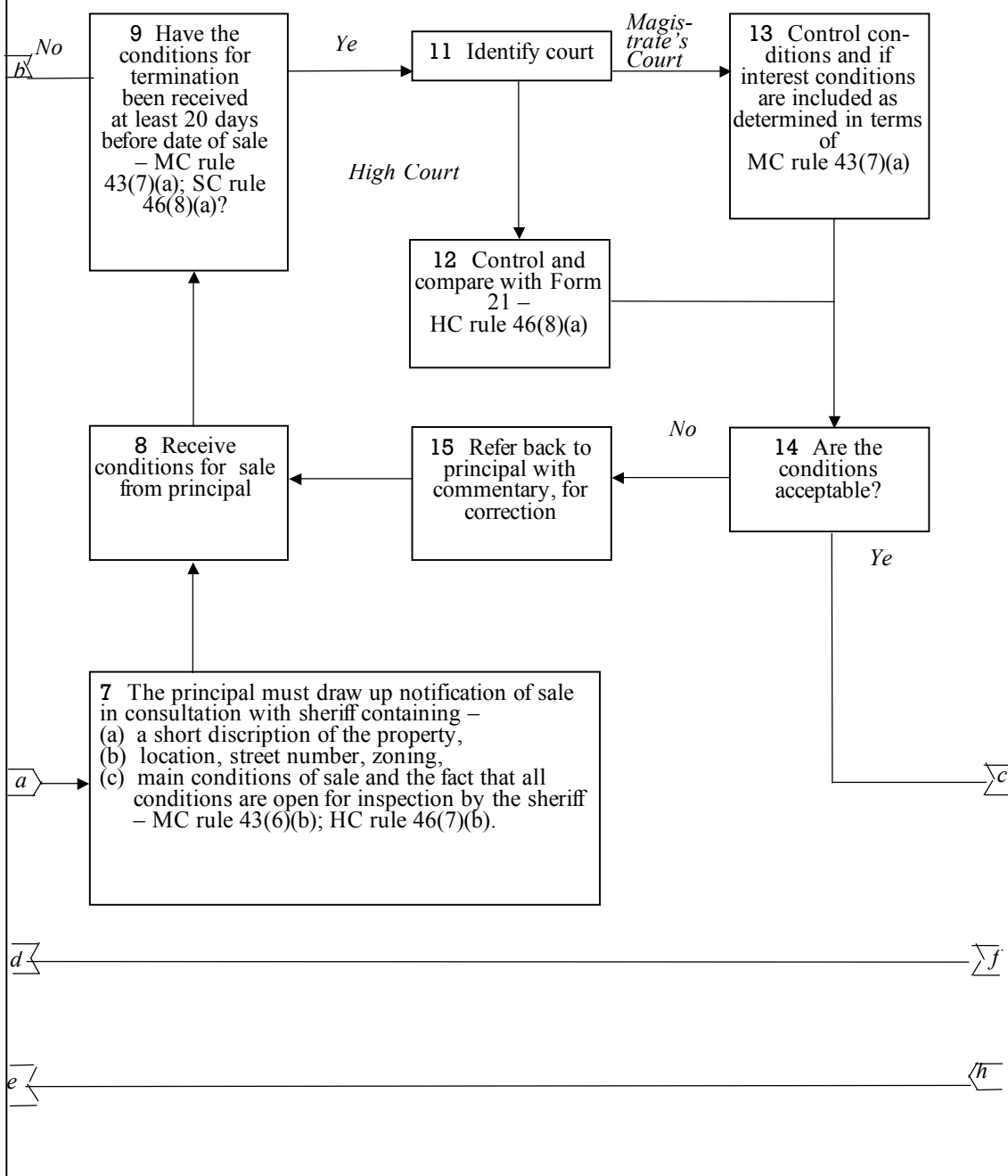
Diagram 11 – Warrant of execution against property – immovable property – Magistrate’s Court, as well as warrant for attachment – immovable property – High Court – sale

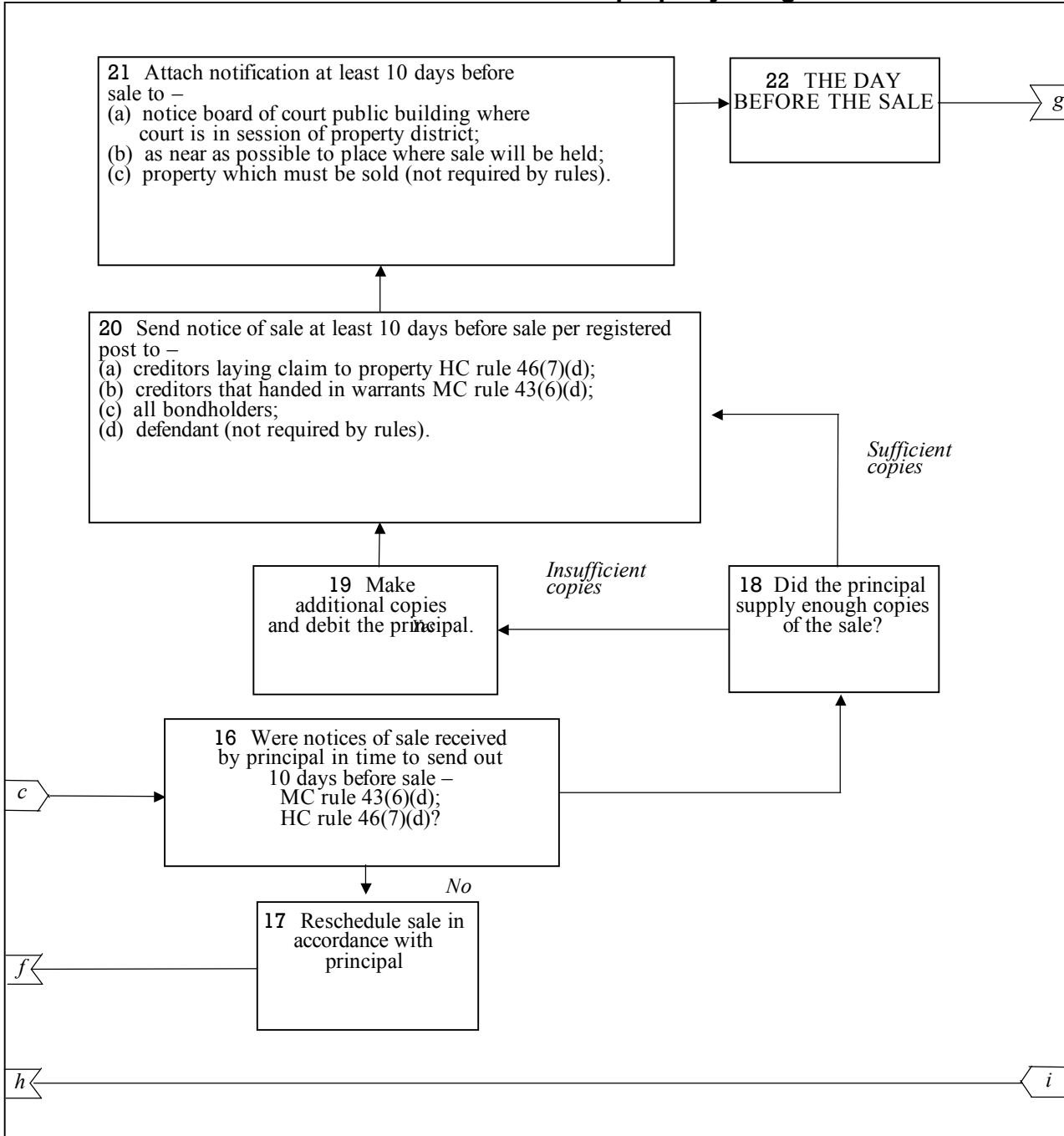
